## 1. What is changing and why?

In 2023, we completed our separation from Johnson & Johnson and became an independent company, Kenvue. As part of this transition, some of our operating subsidiaries that still contain the "Johnson & Johnson" name are being renamed to reflect our Kenvue branding and independence.

Our Company name updates will occur at different times for different legal entities (or "LE's") across all regions.

## 2. What is not changing?

Only the subsidiary company name is changing. The following aspects will NOT change:

- Tax ID/ VAT ID:** No changes to tax identification numbers
- Company Official Numbers (e.g. CNPJ/ RCS/ SIREN/others):** No changes
- Bank Account Details:** No changes to bank accounts
- No change to parent company** – our legal entities are ultimately owned, and continue to be owned, by Kenvue Inc.
- Contracts & Agreements:** All existing agreements remain valid
- Legal Representatives & Board Members:** No changes
- Purchase Order Terms & Conditions:** No changes

## 3. What are the timelines, and which companies are affected?

Below is the list of legal entities which are in scope of name change. All other entities that are not mentioned below will remain as is and are out of scope.

#### **4. When will Suppliers receive the details for each country?**

Kenvue LE Name Change Team will share the details of each country in separate communications closer to the date of company name change for the relevant LE's. As the new company name must in some cases be approved by multiple authorities, the new name will be received, along with the official documentation, closer to (perhaps only a few days before) the effective date. All the details will be provided as soon as they are available via email communications.

#### **5. What is the communication schedule?**

We plan to have two to three pre-communications before each Go Live\*, plus a final communication on the go-live date. As new information and confirmations are published, they will be shared.

\*Go-Live date above refers to the effective date from which supplier partners must invoices using the new name for that specific Kenvue subsidiary.

#### **6. How will Quotations/Orders/Shipping Documentation be affected?**

From the effective date of each LE name change, all new quotations, orders, and shipping documents must be addressed to the new legal name of the relevant company.

International shipping documents, including GMP Certificates of Conformance and Certificates of Analysis, must be updated to reflect the new Kenvue Company Name.

#### **7. Will Quality and Compliance Contracts be updated due to the name change?**

Quality Contracts remain valid after the change of the legal entity name, since the Tax ID will remain the same. The services and responsibilities referenced in the current Quality Contracts and Agreements remain valid and unchanged.

Licenses, certifications, and registrations under the responsibility of your site must be reviewed and updated by you when necessary (e.g. Health Authority manufacturing license, importer licenses, precursor and narcotics licenses, dietary supplement authorization) if they mention Johnson & Johnson.

Control documents (SOPs) and internal records must be reviewed and updated if they mention Johnson & Johnson.

## **8. Will there be any changes to purchase orders (POs) due to company name change?**

**Existing Open POs** and their terms and conditions will remain valid.

**New POs:** Any new PO issued after the effective date will reflect the new Kenvue company name in the Bill to or Ship to sections (wherever relevant).

Some PO numbers may change due to purchasing system updates. You will receive separate communication email regarding these Purchase Orders.

## **9. Will suppliers need a new credit application?**

No, since any LE affected by name change remains the same other than the adoption of the new name, and our ultimate parent company and Tax ID remain unchanged, there is no need for a new credit application. Kenvue will not support any request for new credit application.

## **10. I need a new Tax Exemption certificate. How should I request for it?**

Please connect with the Kenvue Tax representative for your country for assistance on Tax Exemption Certification (if applicable).

## **11. Do I need to make any changes to existing contracts/ agreements?**

All existing agreements (SOW, MSA, PAA, Work Orders, etc.) will remain valid, and no change is required at the time of transition. However, for good record keeping, at the time of any subsequent renewal or amendment, after the date of the LE name change, that new name will be updated in relevant contracts. All new agreements should reflect the new legal entity name from the date of signature.

## **12. Will licenses and regulatory registrations be affected?**

All licenses held by Kenvue will be updated as needed. Suppliers must update any licenses they maintain on behalf of Kenvue (or which mention a J&J legal entity name).

## **13. How should suppliers handle invoices until the go-live date?**

Invoices must follow the current format until the new entity name becomes effective. After the go-live date for any relevant legal entity, all invoices must reflect that new legal entity name.

## **14. Can suppliers issue invoices with the new name before the effective date?**

No. Invoices issued before the go-live date must continue using the current entity name.

## **15. What if a supplier does not update its records in time?**

Suppliers will be advised to promptly update their records if they have not done so after the go-live date. Unfortunately, invoices issued with any “old” company name, after the name change is effective, will have to be rejected. We appreciate supplier’s support as we work through this transition.

## **16. How will suppliers be notified of critical cut-off dates?**

Suppliers will be informed of any transition/ cut-off dates for their respective countries via separate communication emails closer to the transition timing.

## **17. Who should suppliers contact for any questions?**

- All information related to any legal entity name change is shared with supplier partners before the respective Kenvue subsidiary name change dates. If you have any further questions, please reach out to your Kenvue point of contact or account manager.
